

# CE Marking for Windows & Doors

In the UK, it will become law to CE mark most windows from 1 July 2013. The products we supply are not covered within the scope of current CE marking as individual products. They are not subject to a harmonised European product standard or harmonised technical specification.

However, there are three mandatory *Essential Characteristics* that need to be declared by window manufacturers when CE marking; "dangerous substances", "load bearing capacity of safety devices" and "thermal transmittance". Of these, only two are pertinent to hardware and our declarations for them are as follows:

- Dangerous Substances; No products supplied by Titon emit dangerous substances.
- Load Bearing Capacity of Safety Devices; All of the devices listed in the annex will meet or exceed the requirement of a load bearing capacity of 350N for 60 seconds.

Additionally, you will find the supporting documentation for the safety devices as well as certificates for our ISO 9001, ISO 14001, and Health and Safety Policy by visiting [www.titon.co.uk/ce](http://www.titon.co.uk/ce).
